# **Department of Usul-Addin**

The Department was established in 1992. It awards a Bachelor Degree in Usul addin after a successful study of (132) credit hours. Currently, there are 14 faculty members holding a Ph.D degree. It also supervises the Qur'anic Recitation Program (Telawah and Tajweed) with a modern laboratory equipped with computers and audiovisual aids to train students in the field.

At the graduate levels, the Department offers both an M.A. in Usul Addin and a Ph.D. in Tafseer (Qur'anic interpretation, Qur'anic Sciences, and Hadith).

The department also inclouds the holy Quran program connects with teaching recitation of the Quran and memorizing the Surahs, beside the Laberatory of recitation. More over arrangements are put to develop this program to be a department of Qira'at (Quranic Readings) in future in God willing.

Like the other departments of faculty of Shariah and Islamic studies the department participates in general activities toward the faculty, University and the Local Society.

# Department of Us Ul-Addin course description

# Sh Us99: Recitation and Reading of the Quran (Remedial Course)

Concentration is put on reading the holy Quran, manners of recitation, Names of the Arabic alphabet, how to spell and write the Letters by comparison with the quranic way of recision, motions of syntacs... Etc.

#### Sh Us 100: Islamic Culture

Concept of culture in general and Islamic culture in particular , sources , component, impact on individuals, and societies; challenges facing Islamic culture; Islam's attitudes towards these challenges; intellectual invasion; missionary work, Orientalism, westernization, relation between heritage, contemporary and western civilization: obstacles facing resumption of Islamic life and some topics about Islamic thought .

# Sh Us 110: Qur'anic Sciences

Introduction to the Holy Qur'an and bringing to light all aspects related thereof in terms of revelation, date, causes, qualities, location and times of revelation, inscription, writing, translation, various Readings and inimitability of the Qur'an .This Course also explains How the accusations against the Quran must be studed.

#### Sh Us 111, 210, 310: Qur'an Recitation

- A. The Theoretical Part: Introduction: a- Science of cantillation: concept of cantillation, rule, subject benefit, early beginnings of the science of cantillation, solecism, basics of correct recitation, kinds of correct recitation style of Hafs, a brief account of Hafs.
- B. Decorous behavior in reading Qur'an , decorum of listening to Qur'anic recitation, starting with Istia'thah (saying: I take refuge with God from the devil), Basmalah: invoking the name of God (saying: in the Name of God, Most Gracious, Most Merciful), prostration while reciting Qur'an
- C. Applied Part:

It is taken at the end of the course where the student has to recite a part (ju'z,) of the Holy Qur'an to make sure of properly applying the rules of cantillation. The parts prescribed are part 30 (or juz'Amma), part 29, (juz' Tabarak)in Sh Us111, Part27 and 28 in Sh Us210, and Part 25 and 26 in Sh Us310.

#### Sh Us 112: Tafsir (interpretation ) (1)

Exegesis of Parts 29, and 30 (Tabarak and `Amma) of the Holy Qur'an, provided it includes a part of analytical and general interpretation. Division of Qur'anic Parts in accordance with the levels of general interpretation.

#### Sh Us 120: Introduction to Sunnah and its Sciences

Rise of Hadith terminology science and importance thereof. Division of tradition or Hadith in accordance with its various respects, like acceptance, rejection, and causes thereof, categories of Hadith, invalidation and support of narrator's testimony.

# Sh Us 121 :Biography of the Prophet Muhammad and Actions of Arrashidien Caliphs

The course deals briefly with the life of the Arabs in Jahiliyyah, the impact of prophet Muhammad's mission, the importance of studying syrah , the phases of Syrah from the start of Muhammad's mission until his death with emphasis on major events like the Prophet's emigration from Mecca to Medina, the Aqaba oath of allegiance or Bay'ah. Syran of Rashidon caliphs.

# Sh Us 123: (Hadith) (1)

Analytical Study of the forty Nawawi Hadiths in terms of text and ascription to narrators thereof.

#### Sh Us 130: Introduction to Islamic Creed

Definition of creed, its importance, Connection with Sharia, its Characteristics, Sources, methods of study and its effect upon the individual and society.

# Sh Us 211 :interpretation (2)

Interpretation of Sura (6) (a)-An'am): Interpretation of sura 24 (Al-Nur): topics dealt with by the sura, style of the sura, Preparation of some research essays through the sura's interpretation.

#### Sh Us 224: Hadith (2)

The course comprises twenty Hadiths selected from al-Bukhari's" Sahih "taken from the sections of: "The Beginning of Revelation, Learning and Beginning of Creation" with a study of the Hadiths in "Muslim's Sahih" related to the Books of Government, Jehad, dress and ornament, embellishment.

# Sh Us 227: Prophetic Guidance in Etiquette and Parchment

The study of a number of authentic Hadiths selected from the works of Hadith in the field of Islamic morals and good manners, and Hadiths leading to more compassion faith and relation with God which will contribute to building up an Islamic personality and making it accustomed to piety and virtue.

# Sh Us 231: Islamic creed (Aqidah ) (1)

Issues Connect with faith in God, his Existence, believing in his divinty, Names and attributes. The course also deals with the divine destiny and relation with Unity of Lordship.

# Sh Us 231A: Quranic Stories

Concepts of Quranic Stories and distinctions . It should be emphasized on studying some of models connect with Quranic stories Exploring the methodologies of research in Quranic stories, beside that the student must relize The Jewish and Christian Lore and it's impacts on the Quranic stories.

#### Sh Us 232: Ethics in the Quran

This material includes the theoretical foundations of morals such as obligation, Responsibility and social sanction, with applicable modals of morals like honesty, patience, cooperation and etc.

This course gives the differences betweens morals and Quranic philosophy, social and individual Ethics. Some of legacy books about Ethics must be selected to study.

# Sh Us 311: Styles of Rhetoric in Qur'an and Sunnah

In this course emphasis is made on: the most significant characteristics of Arabic which is the language of the Holy Qur'an, the historical phases of rhetoric, study of some Qur'anic and Sunnah characteristic styles.

# Sh Us 312: Inimitability of the holy Qur'an

Meaning of inimitability and importance of studying it. Difference between Prophet Muhammad's miracle—peace be on him - and those of previous prophets. This course shows the stages of challing of the Quran, and sheds light on the history of inimitability research and types.

#### Sh Us 313: Interpretation of Verses that Contain Qur'anic judgments (ordinances)

study of Qur'anic verses related to legal or Shari'a judgments including Ibadat (religious observances) and transactions selected by the course instructor at every semester subsequent to consultation with the concerned department.

# **Sh Us 327:** Tracing the Prophetic Tradition

Introduction to Hadith books, books of men, and how to deal with them, methodologies followed in compiling them, methods of tracing the sources of Hadiths from these books through practical applications in which the teacher participates with the students as much as possible.

#### Sh Us 331: Contemporary Studies in interpretation

This material aims at making aknowledgeable Student at study of the most important efforts and Contemporary studies wich are offered in Ouran interpretation.

It also introduces him to the features, methodologies, several principles of thought, scientific values and Contributions to interpretation movements negatively or positively.

# Sh Us 332: Islamic creed (Aqidah) (2)

Study of the names and attributes of Almighty God, bases of unification of names and attributes, entity attributes, attributes dependent on God's will, information – related to attributes.

#### Sh Us 336: Islamic Sects

Study of the sects whose rise was due to differences on political concepts of Imamate, early Muslims attitude towards basic principles of religion, Kharijites, Shiites. Moreover this course indicates to contemporary sects inside and outside of Islamic countries.

#### Sh Us 337A: Religions and Sects

Studying the Pillars of Faith and their effects as well as studying sects within Islam and reasons led to their appearance. In this course emphasis is put on the ancient pre-Islamic religions.

#### Sh Us 340: Contemporary Studies in prophetic sunnah

This material aims at introducing the student to the efforts and studies wich support the sunnah of prophet Muhammed ( PbUh).

It also explores what the scholars have achieved in the field of the scientific discoveries wich are mentioned in Hadiths, and that strengthens the evidences of prophecy and leads to believe in it too.

Moreover this study will open a new track of knowledge for the stu

#### Sh Us346: Hadiths Connect with Sale

this course deals with Hadiths related to sale, with concentration on the forbidden types of salw with tracing it, in addition to it's Uthenticity (acceptance or refusing), emphasise also is put on studying the rules that are deducted of these.

# Sh Us 415: interpreters Methodologies

Introduction to interpretation and conditions and parts thereof, having an idea about the causes in difference of methods followed by scholars in Qur'anic exegesis showing meanwhile the correct exegetic methodology.

# Sh Us 416: Textual Study from interpretation Books

Selected texts from interpretation books like the Tafsirs of al-Tabari, al-Razi,

Ibn Katheer, Al-Kashaf, al-Baidawi, al-Alusi" Zilal al-Qur'an " and others chosen by the concerned faculty member.

# Sh Us 417: Analytical interpretation

Meaning of analytical history of the usage of this term, methodology of Exegetist in analytical interpretation in terms of revealing the aims of Qur'anic verses.

It is focused on the rules of this type of interpretation and it's Basics, beside that the surahs of the Quran must be studed in terms of meanings, semantics, metaphorics, etc.

# Sh Us 426: Explanation of Rules Hadiths

Thirty authentic Hadiths are chosen by the teacher from Hadith books and sections dealing with Ibadat (religious observances); marriage; divorce and transactions with emphasis on Judgements dealt with by the subject of Hadith.

# Sh Us 428: Traditionists methodologies

Methodologies of recording and clarification of hadith, schools of hadith; Al Bassrah, Al Kofah, Almadinah.

# Sh Us 434: Comparative Religion (1)

Discussion of the concept of religion, social necessity of religion, various theories about the rise of religion: natural, developmental, psychological, and social brief outline of Judaism and Christianity.

#### Sh Us 435: Texts of interpretation and tradition in English Language

Vocabularies and concepts regard with the glorious Quran and Sunnah in English, it is focused on the studying of Texts of Quran interpretation and Hadith in English, and other study Skills.

# Sh Us 436: Contemporary Trend of Thought

Study of contemporary doctrines of thought, causes of development, their impacts on Moslem society; communism, nationalism, democracy, rationality, globalization.

# **Course Description of the Master Degree in UsuLAD Din**

#### Sh Us 601: Research Methods in Islamic Sciences

Principles, rules and methodologies of scientific research and the applications thereof in the field of Islamic studies, inductive, deductive experimental and historical methods, choice, planning, data collection, stages of achievement and sources of research, documentation and academic integrity, compacter and use thereof in Sharia researches, scientific application of what the student has acquired through discussion of some written researches such as academic theses and similar activities in the field of the student's specialization.

#### Sh Us 602: Rhetoric in the Quran and Sunnah

Meaning, Hisotry and most important subjects of rhetoric, exactitude and precision in the style of the Quran and hadith, metaphorical image in the Quran and Hadith, similes in Quran and Sunnah, types of metaphor.

#### Sh Us 610: Studies in Ouranic Sciences

Amplified study of Courses Quranic Revelation, the seven letters and recitations, Precise and ambiguous verses, Quranic calligraphy.

#### Sh Us 611: Studies in Analytical interpretation

Suras and verses to be chosen from the holy Quran and studied in a way that combines language with judgments, social issues etc. with arelated to its topic.

# Sh Us 612: Inimitability of the holy Quran

A Jurisprudential study of challenge phases, types of inimitability; rhetorical, legislative and scientific.

# Sh Us 613: interpretation Through Traditional Evidence and Rational Evidence

Quranic suras and verses are to be chosen and studied in a manner the combines correct transmission of interpretation through text with explicit intellectual interpretation to show congruity between textual and intelligiont through exegesist Major works like those of Al-tabari, Al-Zamakshari and Al- alusi, etc.

#### Sh Us 614: Special Subject in Quranic Stories:

Concept of story in the holy Quran and its relation with inimitability and the educational message and divine guidance, it conveys in addition to revealing the secrets under lying occurrence of a story in more than one sura, the teacher chooses some of these stories and for an in –depth study. And discussion and refutation of some specious arguments.

# Sh Us 615: Topical Interpretation:

Concept, History, magnates and methodology of topical exegesis creation in Quran, verses of preaching (Da'wah), holy war (jihad) and beneficence.

#### **Sh Us 616: Renovation in Interpretation:**

Concept, controls and methods of renovation, top leaders of renovation in tafsir (exegesis) studies in modern times, most significant controls that have to be observed by contemporary exegetist, the teacher chooses some of the topics that have emerged and relation with the holy Quranic lay out.

# Sh Us 620: Studies in Hadith Terminology Science

Concerning the evolution and history of the terminological concepts and types of hadith in terms of ascription and text and relation of this science with other sciences such as usul (foundations), interpretation (tafsir) etc, subjects of this science dealt with by Muslim sects.

#### Sh us 621: Studies in the science of hadith concealed defects:

Defects science: its scope, history and role in the preservation of prophetic Sunnah, rules of this science and methods followed by critics in descovering the defects of hadith. Study of selected specimens of defective hadiths and the main technical terms of defective hadiths, training the students in how to deal critics' texts in this field.

#### Sh Us 622: Hadith Texts (Analytical Studies):

Study of collection of holy hadiths, analysis of items and vocabulary deduction of figh rules and hadith uses from these texts and samples of scholars' contributions to this field.

#### Sh Us 623: Censure and (Commendation)

Study of the most significant terms of censure and commendation and the denotations thereof. Remarkable sayings of jurists on judging men in this particular in this special field, and then acritical study of chains of hadith transmitters through correct controls and sound criteria, discussion of the use of computer in transmission with correct ascriptions..

# Sh Us 624: Studies in the Science of Narrators' History

Science of authoring narrators' biographies in terms of (authorship) and development of writing therein and the bases accredited in writing, content of narrators biographies and acquaintance with the largest numbers bers of authored works in this respect.

# Sh Us 625: Dissimilar (Paradoxical) Hadiths

Study of hadith which seems to be apparently in conflict with one another, with the Holy Quran or with the principles of Sharia, scholars' approaches in dealing with this type of hadiths, history of this science, study of selected specimens, textual study of some accredited reference works.

# Sh Us 626: Study of Ascriptions and Chains of Hadith Narrators

Importance of this branch of learning in documentation of hadith texts, different schools of how to correct them and the stipulated controls and standards with due attention to applied studies in this field.

# Sh Ue 630: Methodological Foundation of creed Study:

The general fundamental tracks followed by scholars in studying Islamic aqidah (creed) through correct transmission and intelligent reasoning, acquainting the student with these fundamentals and scholarly approaches in ascertainment of Aqidah through ancient and modern sources of the subject.

#### Sh Us 631: Studies in Sects:

A Comparative of the main sects in Islamic history: their origins and ramifications, the relation of contemporary sects with the old ones in terms of their preaching (da'wah) and aims, taking into consideration the maintenance of Muslim unity.

# Sh Us 632: Studies in Contemporary Schools of Thought

Study of a set of various contemporary schools of thought spread all over the word with regard to their history ideologies, leading figures, places of proliferation, their accepted and rejected ideas in accordance with Islamic critical creterion.

# Sh Us 633: Special Subject in Religions:

Study of special topics in religion like Judaism, Hinduism, Buddhism and others; their creeds, historical development, sects, and leaders in comparison with Islamic Aqidah.

#### Sh Us 634: Studies in Logic

Development of the science of Logic, attitude of scholastic theologians and Muslim scholars towards its special subjects in logic, compilation, a comparative study of: conceptions, belief, indication, definition and explanatory statements deduction and analogy, study of selected texts from the magnats of this branch of knowledge such as at – Taftazani, ibn Rushed, al – Sijistani and others.

#### Sh Us 635: Studies in Sufism

Selected topics in Sufism and terminologies, thereof, and their discussions in the light of Qur'an and Sunnah.

Sufi orders: their rise and the fundaments and methodologies, their impact and their proliferation all over the world.

# **Course Description**

# Sh Us 701:Research Methods and Text Editing in Islamic Sciences

Scholars' research methods in various stages of academic research; methods of editing manuscripts and texts in Islamic sciences to enable students write in a sober scientific style and research method.

#### Sh Us 702: Linguistic and rhetorical Studies in Qur'an and Sunnah

Characteristics and rhetoric aspects of Qur'anic and matters related thereof; study of some important issues like metaphor, fronin, delaying, etc; study of subjects from both dalail al – Ijaz and Asrar al – Balaghah (evidences of inimitability) and (secrets of rhetoric) by Imam Abdul-Qahir al-Jurjani, Language and metaphors of Hadith, rhetoric studies of Hadith and using it as an authority in the field of linguistic and grammatical studies; some applied selected topics.

# Sh Us 703: Qur'anic and Hadith Studies in English

Study of some writings in English dealing with tafsir, (interpretation), Qur'anic sciences, hadith sciences, how far English expressions agree with the meanings and secrets thereof.

#### Sh Us 710 :Advanced Studies in Qur'anic Sciences

Study of some Qur'anic sciences that need extensive and in-depth treatment. Discussion of views presented about their problems and ramifications like abrogated and abrogating Qur'anic verses, the seven ways of Qur'anic recitation, translation of Qur'an etc..

#### Sh Us 711: Trends of interpretation and Commentators' Methods

Tafsir trends such as rhetorical, intellectual, jurisprudential and other trends in various periods; introduction to commentators' methodologies in the light of such trends; selected examples from some methodologies (Tabari, Zamakhshari, Razi, Abu Hayyan, ibn Ashur, Rasheed Rida....).

# Sh Us 712: Advanced Studies in Analytical interpretation

Analytical study of some Qur'anic suras and ayat (verses) in terms of vocabulary, derivation, parsing, morphology, rhetorical, niceties, structure denotations, rules embodied in the Qur'anic verse in a manner that enables the student understand and appreciate Qur'anic arrangement.

#### Sh Us 713 :Advanced Studies in Qur'an Inimitability

Qur'anic inimitability in terms of types, such as rhetorical, legal and scientific.... with applied illustrations of some aspects of inimitability; efforts of scholars to reveal these aspects particularly those related to scientific inimitability.

#### Sh Us 714: Contemporary Studies in interpretation and Qur'anic Sciences

Approaching contemporary studies in Tafsir and Qur'anic sciences from several angles and considerations whether those raising specious arguments or those defending tafsir and its foundations to enable the student discuss specious arguments and issues through sound argument and conclusive proof.

# Sh Us 715: Studies in Topical interpretation

History of topical exegesis and scholars' approaches in dealing with Qur'anic topics, exposition of Qur'an's guidance in every topic it deals with through its verses; study of applied examples that help the student understand association between the verses of the same topic such as the verses dealing with creation, cosmic norms, jihad etc.

# Sh Us 716: Studies in Qur'anic Readings Recitations

Study of Qur'anic recitations in terms of types, and controls; directing these recitations towards service of tafsir, and revelation of some aspects of inimitability in differences between recitations; applied study of a number of Qur'anic verses through various recitations.

#### Sh Us717: Advanced Study of Aqidah Verses

Objective study of some aqidah (faith) verses and pointing out the Aqidah issues therien and reasons why scholars disagreed in understanding them; proof of the Sunni Aqidah and refutation of those who act against them through showing the explicit and implicit denotation of these verses.

# **Sh Us 718 : Advanced Textual Study in Tafsir (interpretation)**

Commentators' approaches in comprehending Qur'anic context, the methodologies they adopted, their ideological and jurisprudential doctrines and the impact thereof on their works.

#### Sh Us719 :Studies in Multi-Faceted Our'anic Texts

Meaning of "multi-faceted" in language and terminology, need to study and comprehend this term through reading what scholars have written about the verses whose apparent terms have raised problems; refutation of specious arguments; study of applied example from the book" Ta'wil Mushkil al-Qur'an "various interpretation of Qur'anic text) by ibn Qutaybah and other authors.

#### Sh Us720 :Advanced study of Rules' Verses

Methodical foundations of deducting jurisprudentially rules from Qur'anic verses through grasping the context and its implied questions and ramifications; study of applied Examples selected by the teacher from works written on Qur'anic rules (al-Qurtubi, ibn al-Arabi and al-Jassas.

#### ShH 730: Studies in Usul (foundations) of Hadith.

Indepth study of special subjects in Hadith sciences like checking the concept of out hentic hadith, fairly authentic Hadiths, renounced and irregular hadiths, concept of trust; Sahaba (prophet Muhammad's Companions) authenticity and exactitude, idraj (irregularity in the hadith's text or ascription); irsal (omission of some terms by a tabi'i hadith narrators; diversity of hadith some special terms; development of terminology in hadith sciences; their historical sequence and concept as viewed by all types of critics.

# Sh Us 731: Criticism among Hadith Narrators.

Rise and development of criticism among hadith narrators; how they criticise the narrator and the narrated text; critics, methodologies in judging narrated accounts, rational criticism by hadith narrators, comparison between hadith narrators, and historians, critical approach; study of samples of orientalists criticism, with special attention paid to the text.

# Sh Us 732 : Specialized Study of Analytical Hadith

Analytical study of some hadiths in terms of vocabulary, parsing aspects, rhetorical niceties, structures' connotations and the judgements and maxims they contain through studying applied examples from the Sahihs of al Bukhari and Muslim.

#### Sh Us 733 :Studies in Hadith ilal (Concealed Defects)

Investigation of the concepts of ilal (concealed defects) sciences among critics through reference to their original Sources therein; difference between this science and the science of censure and commendation definition and examples of narratives suffering from concealed defects unveiled by specialist scholars; authors methodologies in the science of hadith concedaled defects; evaluation of what terminology books say about it; methods of concealed defects identification; some problems in this science such as disagreement about narrator; condemnation and rejection of narration by authorities; concealed defects rising from general narration, imporovement of ascription, similarities in concealed defects; students are requested to make personal extensive reading in various work about concealed defects authored by people like ibn aL- madini, Ahmad al- Dar- qutni, Tirmidhi, ibn Abi Hatim and others.

# Sh Us 734: Advanced Study of Hadith Narrators Methodologies

study of Hadith narrators, methodologies in the first three centuries (hijri calendar ), and subsequent authored work in various ages; methodologies adopted by Hadith narrators in their authorship whitin the frame work of Various trends in each period through studying applied examples of narrators methodologies like al- Bukhari, Muslim, al- Tabarani , ibn Hagar and others

#### Sh Us 735 :Study of Maghazi (military expeditions) and Siyar (biographies)

Relation of historiography with maghazi (military expeditions) and siyar (biographies); historical development of the study of maghazi and siyar evaluation of the studies of each stage; schools of writing and outhorship of prophet Muhammad biography like Hadith narrators school, historians school, and the school of those who exclusively dedicated their work to authorship about maghazi and siyar; orientalists efforts and views about siyar and maghazi and evaluation of these offorts.

#### Sh Us 736: Sunnah in Contemporary Studies

Orientaltists efforts and writing about Prophet Muhammad's Sunnah ; views of some contemporary writers about sunnah in term of writing and authoritativeness discussed of orientalists; contemporary school efforts in sunnah books editing and computerization and making them opitmally accessible to Muslim specalists and others through the use of Internet .

#### Sh Us 737: Specilized Study of Jurisprudential Hadiths

Study of collection of jurisprudentially significant comprehensive Hadith texts stressing the importance of Hadith in the field of jurisprudential studies; Ahkam's hadiths and impact of such hadiths on differences between jurists.

#### Sh Us 738: Studies in Topical Hadith

Definition of topical hadith; study of the history of authoring on this comprehensive;

checks that must be present in this science; study of applied examples from hadith books.

#### Sh Us 739 : Advanced Study in Hadith Texts

Indepth study of texts, commentaries and methodologies of authors in this science arrangement , explanation , deduction of judgements and issuing such judgements, their commitment to the holy porphetic expressions ; applied examples of commentaries of al Bukhari , Muslim and other Hadith books

#### Sh Us 740: Studies in Paradoxical Hadiths

Science of diverse Hadiths, development thereof; problem of language and terminolgy, need for studying it through reading what was written by Hadith and Aqidah scholars like ibn Qutaybah, ibn Fork and others and discussion of issues raised about this subject by earlier and contemporary authors.

# Sh Us 741: Advanced Study of Aqidah (Muslim creed ) Hadiths

objective analytical study of some hadiths about Aqidah from sahih's and sunan's books with exposition of the Aqidah Issues and causes of differences between scholars in understanding them, confirmation of the Aqidah of the Sunni people, replying to those who contradict through the hadith oral expressions in terms of system and comprehension.

# Sh Us 742 :Jurisprudential Ttrends of Hadith Narrators

Studying Jurisprudential Trends of Traditionalists in order to uncover their approach in terms of its formation, rise, and stability, The impute of that on various works of Hadith, and the general traits that govern the Traditionalists upon deduction. It requies, also, the study of a number of controversial issues between Traditionalists and Jurists, requesting students to read for themselves in a manner that intensifies knowledge, widens intellectual capacities and helps faculties of deduction and understanding.

## Sh Us 743: Hadith Schools

Study of Hadith schools that rose in the Muslim world in terms of the Sahabah number affiliated with each school the number of the Tabii's (follwers of prophet Muhammads Sahabah) distinctive qualities of each with regard to Hadith; impact of intellectual and political movements in schools of Hadith Science, Hadith Schools of Madinah, Kufah, Basrah, Damascus, Mecca, Egypt, Khurasan, Africa, Andalus, Taif, Yamamah and Yemen.
